Treasurer's Report – was reviewed by the board. A motion was made by Roger/JJ to approve the treasurer's report. Motion carried.

Road Report – JJ mentioned the bad potholes at Mielke and Brave, we should check on those. On Brave just south of Brandon Kuphal's place a sink hole has started there. A.F.Gelhar is looking to put a new driveway on the East portion of their property which would come out on Mackford Hill Road. The town will need to look at an agreement with Gelhar to make sure the road doesn't get destroyed.

Lake Maria Boat Motor Ordinance – The Town of Manchester has voted to repeal their ordinance with Lake Maria Boat Motor. The board has also decided to repeal the ordinance as well. Clerk Mehn will double check with Attorney Sondalle if the township is allowed to just repeal their ordinance. A motion was made by JJ/Roger to repeal the ordinance as long as Attorney Sondalle approves it.

Fire Department – We will be paying \$55,210.3 at our December meeting for the new first truck. The fire department is looking to build more storage buildings for their equipment. Also the Dalton/Kingston area is looking to join forces with the Grand River Fire District.
