

Town of Mackford
Town Board Meeting Minutes
July 21, 2025

The meeting was held at the Town of Mackford Town Hall, N2270 County Road A, Markesan, WI 53946. Notice of this meeting was given by posting on the Town Hall message board and the Town's website.

Call to Order

- Chairman Davison called the regular town board meeting to order at 7:00 PM. Supervisor Roger Schure was absent.. There was 1 employee also in attendance.
- Roll Call: Steve Davison – 2, JJ Gigstead – 1, Roger Schure– 0, Brittany Krentz– 1, Andrea Dillie – 1

Agenda

- The agenda was read. Supervisor Gigstead made a motion to accept the agenda as presented. Chairman Davison seconded; the motion carried 2-0.

Minutes

- The minutes from the June 16th town board meeting were reviewed. Supervisor Gigstead made a motion to accept the minutes as presented. Chairman Davison seconded; the motion carried 2-0.

Public Comments (3-Minute Limit)

- Wesley James noted that he cut back a fallen tree on Union Road.

Vouchers/Bills

- Chairman Davison made a motion to approve the vouchers/bills. Supervisor Gigstead seconded; the motion carried 2-0.

Treasurer's Report

- The board reviewed the treasurer's report. Supervisor Gigstead made a motion to approve the treasurer's report as presented. Chairman Davison seconded; the motion carried 2-0.

Old Business

Road Report

- The Wisconsin DOT inspected the Village Road bridge. Some maintenance recommended included sweeping the deck and cutting the brush back.

New Business

Town Road Weight Restrictions

- Matthew Kirkman emailed asking for clarification on road weight limits in regards to septage haulers. He noted the Green Lake County Highway Department sets their seasonal max weight at 4 tons per axle, not to exceed 10 tons gross. Also, this year the County Highway Department has dropped its seasonal weight limits in April. Chairman Davison made a motion to formally exempt septage haulers following the Green Lake County guidelines. Supervisor Gigstead seconded; the motion carried 2-0.

Grand River Fire Dept Boat Purchase

- The fire dept purchased a boat to replace the current boat. They were able to obtain this using fund raiser money. The price was \$11,000. They are asking the board to accept this boat into the fleet of vehicles. They expect the insurance to be higher due to being a newer model and may also need a trailer for it. The next fire dept meeting is in August. No action taken at this time.

Power Lines Meeting

- Chairman Davison received notice of an upcoming meeting to discuss power lines. Unsure if it's updating current lines or adding new lines.

Upcoming Events

- The board will discuss the budget at the October board meeting with the budget hearing being held on November 17th before the regular town board meeting.

Adjourn: Supervisor Gigstead moved to adjourn the meeting. Chairman Davison seconded; the motion carried 2-0 to adjourn at 7:41 PM
