**Budget Hearing & Electors Meeting**

- A motion was made by Wesley James/ seconded by Tim Dillie to approve the 2025 total town levy to be collected in 2026 for the Town of Mackford in the amount of \$161,677 and to approve the 2026 Town of Mackford budget. The motion carried 7 Ayes, 0 Nays, 0 Abstentions

- Chairman Davison contacted Rural Ins to see if there is any coverage for the damage that happened on Union Road. They have not called back yet.
